

# NOTICE

regarding the processing of personal data (Art. 13 Leg. Decree 196/2003)

**Objective of the notice:** inform everyone (hereafter the Interested Parties) about how their personal data that is collected and processed by Mobil Plastic S.p.A. is managed

**Processing purposes and methods:** personal data is collected and processed for current administrative and accounting purposes. Sensitive or judicial data is not processed. The personal data can be processed with or without the use of electronic instruments.

**Mandatory or optional nature of providing the data:** the personal data is necessary to comply with the contractual requirements or to carry out the institutional functions within the limits required by municipal, provincial and regional laws and regulations.

**The possible refusal to respond to the request for personal data** may make it impossible to carry out the service requested by the interested party or block the institutional procedure.

**The personal data may be accessed** by the Managers and Officers that the Data Controller has identified through a suitable procedure. They may only access the data for which they have received a specific appointment.  
The list of people appointed to process the personal data may be requested from Mobil Plastic S.p.A. only in relation to the rights of the interested party.

**The personal data may only be communicated** for current administrative and accounting purposes to third parties or due to a specific municipal, provincial or regional laws or regulations.

**Personal data is not distributed.**

**All interested parties have the right to access their personal data** based on Art. 7 of Leg. Decree 196/2003, as indicated below in the original form:

1. Interested parties have the right to receive confirmation regarding the existence or otherwise of personal data concerning them, even if not yet recorded, and its communication in an intelligible form;
2. Interested parties have the right to obtain information regarding:
  - a) the origin of the personal data;
  - b) processing purposes and methods;
  - c) the applied logic in the case processing was done using electronic instruments;
  - d) identification data of the data controller, managers and representatives designated pursuant to article 5, paragraph 2;
  - e) the parties or the category or parties to whom the personal data can be communicated or who could become aware of it as the designated representative in the territory of the State, or as managers or appointees.
3. Interested parties have the right to obtain:
  - a) the update, correction or, if requested, the integration of data;
  - b) the cancellation, transformation into an anonymous form and the blocking of the data processed in violation of law, including the data that does not need to be stored for the purposes for which the data is collected or subsequently processed;
  - c) the acknowledgement that the operations specified in sections a) and b) have been made known, also with regard to their content, to those individuals to whom the data has been communicated or distributed, except in the case that this fulfilment is impossible or involves an effort that is clearly disproportionate in comparison to the protected right.
4. Interested parties have the right to fully or partially object:
  - a) for legitimate reasons, to the processing of the personal data concerning them, even if pertinent to the purpose for which it was collected;
  - b) to the processing of personal data concerning them for purposes of sending advertising or direct sales material or for market research or marketing communications.

**The Data Controller** is Mobil Plastic S.p.A. who appointed Mr. Lugani Roberto, who can be contacted at the company's offices, as the person responsible for processing personal data.
